- Covid-19 Update
  - Mr. Herman discussed the transition to remote learning has been relatively smooth. He appreciates
    Parents and Staff for being flexible. We may need to extend remote learning past Christmas. There
    is potential for Richland County to go Purple this week during Governor DeWine's update.
  - Many districts have followed the move to remote learning.

  - o Regarding the air purification project that we have been investigating, Mr. Eric Baltzell from Garmann/Miller provided information regarding the quotes received.
