ADMINISTRATIVE INFORMATION ITEMS

Mr. Herman updated the board:

- Semi-Annual Bullying Report was distributed to all Board Members
- Covid 19 update:

19 cases reported last week, 12 positive cases this week, running on average 12% absenteeism last week and around 16% this week.

Moving forward at this point will monitor on a daily basis

Isolation guidelines have decreased the amount of quarantine

Mr. Herman asked for suggestions if cases go up drastically.

Majority are against mask mandate, would like to leave it to the parents to decide for their own children.

Mrs. Arnold asked if remote was an option. Mr. Herman responded that currently it could be used if needed for short term only. The school would need to see 30% or more absenteeism before something would need to be figured out. Mrs. Arnold is not in favor of remote or short term day closures.

- Outdoor Camp update Mrs. Case presented that both 6th and 7th grade students will be going this year. Mrs. Case also went to the sustaining fund to submit a request to see if a portion of the parents' part could be covered. The LSSF granted the entire parents share would be paid. Mrs. Case did say that Camp Nuhop has COVID guidelines in place to help minimize the risk of transmission. The camp will run from March 29 through April 1st. Lucas Schools will be the only district at camp at that time. Any students that are choosing to not go will have a normal school day structure at the school during that time.
- Boiler Update Mr. Sauder updated the Board that the boilers that were initially approved were no longer in stock.
 Standard Plumbing has offered new boilers that are currently in stock. The revised version is very similar to the originally approved quote. Mrs. Arnold questioned the urgency of replacement. Mr. Sauder mentioned that it is very difficult to get in and clean out the burners. Conclusion was to proceed with replacement and to go with the in-stock boilers.
- Track Project Update Eric Baltzell addressed the Board that Vasco has tentatively scheduled Lucas for Track replacement. A detailed price will be forthcoming. If track project is approved, replacement could begin in April and be completed by July.
- January is Board Appreciation Month. A Thank you was expressed to the Board for their service and support of the school.
