Mr. Herman updated the board:

- The bear mount is on display in the Middle School Library.
- Mr. Herman acknowledged and congratulated Coach Finley and wrestler Zane Finley for being the Districts 1st state qualifier in Wrestling.

There was an incident that occurred on Interstate 71 while Coach Finley was in route to the Columbus State Wrestling Tournament. Coach Finley assured the Board that everyone in his car was shaken up over the incident but were all okay. Coach Finley was able to continue on to the tournament.

- Galina Maklakova appreciated all the students and staff that has stopped by to check on her during this time of unrest in the Ukraine.
- COVID Update Seeing relief from the CDC regarding Transportation with masking ending March 1st, 2022 Only one case has been reported in the last month.

We are no longer required to report cases to the Richland Department of Health unless the nurse does the test or an outbreak occurs.

Extended Learning Update-Kaitlyn Fraley

This program has been a move from the Reading Recovery to the Science of Reading and phonics emphasis. Initially three teachers were hired for this program but one resigned prior to the start. The goal is to replace that third by the start of 2022-2023 school year.

Primary focus is K-5 with currently 56 students. Students are served in small group pull-out and one-on-one. Currently Reading is the focus, but the goal is to increase Math services.

We hope to expand the program to include 6th and 7th grades.

May 12th is Literacy Night in the Middle School Gym. Teachers will be doing stations.

Mr. Herman added that being able to expand the former program of (K-2) to the new program (K-5) has allowed for more students to get the help they need.

Mr. Herman plans on posting for the 3rd teacher position right away.

Garmann Miller Update for Track

The track does need to have the top 3" milled off. Eric mentioned that a couple of companies that had been contacted were not responsive. Howland provided a quote. Mr. Herman asked if the board would be interested in a special meeting if another quote is obtained to continue to move forward with project.

The project will entail excavating, putting down asphalt, wait 30 days, put down surfacing and then sit another 30 days and paint. Painting could be put off until after football season if weather holds off.

Mrs. Arnold asked about the regrade of the field. Home side will need to cut into the grass. There will be some cost associated with the repairs to the outer edge of the football field where it meets the track.

Mr. Camp questioned the start time. Eric felt that May 23rd could potentially be the guaranteed start date of project if approved. Mr. Camp commented that we need something decent for the kids to practice on.

Garmann Miller Update for Building Project

Eric Baltzell presented a building concept to the Board. This was created to give vision concept of what the new building could look like. The actual design and planning stage take a year.

Mrs. Arnold wondered if anything can be incorporated from the old building for the nostalgia. It was responded that this is a common practice and that it would take working with the construction manager to incorporate pieces into the new building.
