Yes. We have convened action teams in each county (Richland, Morrow and Crawford). These teams are chaired by business, chamber or workforce development leadership. They meet monthly in between BAC full council meetings. Some of our key business partner positions have experienced a change. Richland Youth and Family Council and Area 10 Workforce Development Board leaders have transitioned to interim directors. The Crawford Partnership Community Development Director position is currently unfilled.

This information is used to guide programming and partnerships. The Crawford Partnership (EDC) in Crawford County began to convene a BAC that includes some MidOhio districts. MidOhio BAC representatives attend these meetings to share information, and have provided programming to all Crawford County Schools regardless of affiliation. SPARC Council has been added to BAC meetings, and representatives from MidOhio BAC attend SPARC Council meetings.
